

APPLICATION FOR CONGREGATION AFFILIATION

Your application to become a Vanguard Ministries Partner Church should include the following:

- 1. A completed Vanguard Ministries Congregation Affiliation form.
- 2. A copy of the congregation's constitution and by-laws.
- 3. Copies of the congregation's financial reports for the last three years.
- 4. A check for the \$100.00 initial processing fee.

Please allow at least two full months for processing and notification regarding your application.

Follow-up Process

Consideration of your application includes an accompanying follow-up process:

- 1. Vanguard Ministries will notify you in writing of their recommendation concerning your application.
- 2. Candidate churches who are accepted for affiliation with Vanguard Ministries will begin the member church process (see document).
- 3. Confirmed congregations will receive a framed certificate showing their status as a Vanguard Partner Church or Participating Church.
